**Late Pick Up Fee:** A late fee is paid at pickup and charged \$15 for every 5 minute increment after **15 minutes** of class dismissal.

### Tuition (September to June):

1 day/week for \$175/month

2 days/week for \$250/month

- Tuition payments are paid monthly, one month in advance.
- Payments are prorated if registering after classes have started.
- If withdrawing from the class, a written notice must be provided to Student Accounts, [student.accounts@rainierchristian.org](mailto:student.accounts@rainierchristian.org) at least 5 days before the next tuition due date.
- Late Fee: A \$25 late fee may be charged for accounts more than 15 days past due.

**Q: Can my family visit to see the Maker Space program before registering?**
